Kathy Cherniawsky

Ms. Cherniawsky obtained her Master of Laws Degree at the University of Alberta. She taught classes at the University of Alberta, Grant MacEwan University, and NAIT, and worked in private practice in Edmonton, with a focus on administrative law.
